**CIRCULAR**

- Sub:** Fulfilling the conditions for obtaining Performance Grants under 14<sup>th</sup> Finance Commission for the period of 2017-18 to 2019-20.

In order to obtain the 14<sup>th</sup> Finance Commission Performance Grants are released based on the guidelines cited in references (3). Government of India has observed guidelines of all the State Governments in reference (4) and also in reference(6), (7) and (8) the State Government has included additional conditions as per Government of India guidelines. Based on the guidelines issued by the Central Government Gram Panchayaths have to fulfil the following two conditions:

- The Gram Panchayaths will have to submit information related to Own Source Revenue(OSR) for the previous three years to the year of claim, submission of Audited Accounts for the year corresponding to two years preceding the year of claim.
- Preparation of plan for FFC funds utilization and inclusion of the same in GPDP.
- Uploading of FFC sector wise expenditure in the FFC dash board are obtained.
- Based on the figures of increase in OSR for the year 2015-16 over 2014-15 and ODF & children immunization status.



Evaluation criteria for disbursal of FFC Performance Grant (PG) to GPs for 2017-18 to 2019-20.

2. The evaluation of those GPs who have satisfied all the above four criteria will be carried out as per the scoring system given below:

\*Sustainability of ODF status from next year will be criteria for GPs having become ODF in the year.

### 3. Distribution to Performance Grants to GPs.

PG distribution to GPs based on their score shall be made as per details given in the following table:

Score	Eligible Quantum of PG
Upto 49	50% of Allocation
50 upto 60	70% of Allocation
61 upto 70	80% of Allocation
71 and above	100% of Allocation



4. Any undistributed amount, after the above allocations as per para-3 including those of ineligible GPs, will be redistributed only amongst GPs scoring 50 or above proportionately on the basis of weighted average of the score obtained by the GP with respect to the overall weightage.

**Procedure:**

1. To obtain the Performance Grants for the year 2017-18, audited annual accounts for the year 2015-16 have to be submitted.
2. Audited annual accounts means "accounts audited by Local Audit Circle".
3. Gram Panchayat "Own Revenue" means collection of revenue from all tax and non-tax sources.
4. Increase in own revenue means, revenue collected as per Schedule IV to Section 199 of the Karnataka Panchayath Raj Act 1993 and license fees collected as per Section 70 of the Karnataka Gram Swaraj and Panchayath Raj Act 1993 and also rentals from own assets. To claim the performance Grants, the audited accounts required for Performance Grants in 2017-18 will be for the year 2015-16 and so on.
5. Every year the Chief Executive Officers, Zilla Panchayat shall consolidate the information as per the guidelines issued and shall submit it to the Government before the end of May. The consolidated statement of all the districts will be submitted to Government of India by end of August.
6. These instructions will be enforced for the period 2015-16 to 2019-20 i.e., 14<sup>th</sup> Finance Commission award period.
7. The Performance Grants shall be utilised for the purpose indicated in the General Basic Grants GOI Guidelines dated: 08-10-2015 and GOK Circular RDP 75 GPS 2016, dated:07-12-2017.
