
The Karnataka Rural Livelihoods Promotion Society (KSRLPS), under the aegis of the Karnataka Nutrition Mission, with support from the World Bank and the Japan Social Development Fund (JSDF) is implementing a Multi-Sectoral Nutrition Pilot Project in two Blocks of Karnataka, namely Devadurga in Raichur District and Chincholi in Gulbarga District. The pilots are designed based on existing pilots being implemented under the Karnataka Nutrition Mission in Gubbi, Shikaripura and Bellary Rural taluks of Tumkur, Shimoga and Bellary Districts respectively by the Karnataka Nutrition Mission.

The Pilot aims at improving nutrition outcomes in children 0-3 years of age, adopting a life cycle approach, focusing on adolescent girls, pregnant and lactating women and children 0-3 years of age. It focuses on the proximate determinants of nutrition by providing daily nutrition food supplements to under-nourished children, adolescent girls and pregnant and lactating women on the one hand; and places an equally strong focus on intermediate determinants of nutrition by implementing an intensive behaviour change communication strategy to improve household behaviours and access to services on the other hand.

**Innovative Project- Feasibility Study of Introducing Low Cost EDF in the Market through the Private Sector**

One of the Innovative Projects proposed within the JSDF/World Bank assisted Karnataka Multi-Sectoral Nutrition Pilot Project is to conduct a Feasibility Study of introducing Low Cost EDF in the market through the Private Sector.

One of the major causes of under nutrition and calorie-protein-micronutrient deficiency among large sections of our population, especially the poorest 30-40 percent, is that there is presently a complete vacuum in the market for low cost, fortified energy foods for BPL families.

The daily diets of the poorest families are meagre, and can at best qualify as subsistence diets. For lack of money and knowledge, the families are not able to provide nutrition required for healthy growth of children and adolescents during rapid growth periods, women during pregnancy and lactation, for all age groups of both genders during or after illness, and complementary food for infants after 6 months of age.

They are already providing several varieties of expensive protein and energy dense foods for children and adults of the more affluent classes. For BPL populations of all age groups and both genders, there is presently a huge market vacuum for low-cost energy foods. Unfortunately, this vacuum has been filled up by junk foods and tobacco based products that are marketed aggressively. Evidence from rural areas also reveals that the poor are forced to purchase expensive energy foods, the only ones available in the market, when they are faced with a serious health emergency or when acute malnutrition becomes life threatening, sometimes spending their entire week's wages for purchasing these products.

The objective of this Consultancy is to conduct a detailed study a) whether the family is aware of nutrition needs. b) What is the monthly spending on food, c) Awareness about girls, pregnant & lactating mother etc., d) Awareness about dietary food available in the market etc., special nutrition dietary needs of the age groups 0-3, 3-6, adolescent the need and assessment of demand, the market entry strategy, and the investment feasibility, to address the vacuum in the market for low cost, fortified energy foods for BPL families, which is confirmed by empirical evidence emerging from the field, especially in respect of chronically under nourished and wasted children under 3 years.

The implementation period is eight months (8 months) after signing Contract.


The Karnataka State Rural Livelihood Promotion Society, Department of Rural Development and Panchayat Raj, Bangalore now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Service of conducting the "Feasibility Study of introducing Low Cost EDF in the market through the Private Sector."

Interested Consultants shall provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

**I. The short listing criteria are:**

**1. General Conditions:**

- The Agency shall be incorporated & registered in India, under Societies Act or any Academic Department which is affiliated with an Agriculture University and/ or any organization which is actively involved in the academic related work shall be in operation in India for a minimum of 5 years

- The Organization shall not be involved in any major litigation that may have an impact of affecting or compromising the delivery of services as required under this REOI
- The Organization shall not have been blacklisted by any Central/State Government/Ministry in India in the last 5 years

## 2. Pre Qualification

- The agency should have a registered / head office in India
- The Agency should have a turnover of not less than Rs. 50 lakhs each year in the last three Financial Years (2013-14, 2014-15 & 2015-16). (Audited Financial Statements i.e., Balance sheet and profit and loss account accompanied by a Certificate from External Auditors (CA's Certificate) has to be submitted )
- The Agency should submit a copy of the IT Returns filed for the last three Assessment Years (2013-14, 2014-15 & 2015-16).

## 3. Technical Qualification:

- The Agency should have at least 5 years experience in Agri Business and Market Research and Feasibility Study in the Agri Business Marketing Sectors (documents should be enclosed).

**II.** The Agency shall submit the Signatory Authority Certificate, Undertaking on Litigation, Undertaking Blacklisting with Covering letter in the prescribed forms (Annexure Form - I to IV) attached to the EOI.

## **III. General Information:**

**A. 1.** Consortium/Joint Ventures are not allowed under this project.

**2.** Sub-Contracting is NOT allowed.

**3.** All documents including all the pages of the proposal shall be signed by the Head of the organisations or her/his authorized signatory. (Documentary evidence of authorization to be provided).

**B.** *The geographical coverage, sampling & the methodology is not defined in the TOR with an intension to get it on discussion with the bidders. Therefore, the shortlisted bidders will be invited for a pre bid meeting to discuss & finalise the geographical coverage, sampling & methodology to be adopted. On finalising this, the amended TOR will be issued for submitting the technical & financial proposal.*

The RFP will be issued to the shortlisted firms. Shortlisted firms shall submit Technical and Financial Proposals. The selection of the firms will be made in QCBS Method as per the Consultant guidelines.


