

**PROCEEDINGS OF THE SLSSC MEETING HELD ON 07/03/2013 AT BANGALORE UNDER THE CHAIRMANSHIP OF  
PRINCIPAL SECRETARY TO GOVERNMENT, RDPR DEPARTMENT**

The Chief Engineer, PRED welcomed all the SLSSC members present for the meeting. With the permission of the Chair the CE, PRED gave a Ppt presentation on the progress made under NRDWP (Coverage, Quality & MVS) under the following headings:



Decision:

After reviewing the Progress of Targets & Achievements under NRDWP, the following decisions were taken:

- 1) The Yearly Data Updation (YDU) Survey Report should be finalized by end of 15<sup>th</sup> April 2013 and entries made in the IMIS website.
- 2) The Action Plan for water supply should be finalized by the end of 30<sup>th</sup> April 2013 as done in other Head of Accounts/Departments.
- 3) The tentative Allocation for the year 2013-14 should be communicated within 15 days to all the Zilla Panchayaths & P.R.E. Divisions.
- 4) The Chairman observed poor progress under Support Activity and WQM&SP Component under NRDWP. It was decided to arrange a day's workshop for CEOs and SEs about Support Activity in April.
- 5) The progress of Water Supply Schemes for Schools & Anganwadies in D.Kannada, Mysore & Chamarajanagar Districts was below 30%. It was decided to expedite the progress and make necessary entries in the IMIS.
- 6) It was decided to take up 10,000 Water Supply Schemes to Anganwadis during 2013-14.
- 7) The Scheme-wise review of 67 Multi-village schemes targetted for 2012-13 was made and SEs were instructed to adhere to the programme fixed and expedite progress wherever slow.
- 8) The waste water management in Defluoridation Plants is to be looked into and the most efficient technology to be adopted. However, it was decided to continue implementation of R.O. System D.F. Plants for the year 2013-14.
- 9) Expenditure under Sustainability is only Rs.53.00 Cr. against a release of Rs.74.00 Cr. However, CE informed that some districts have shown poor progress and some districts need additional amount. So it was decided to authorize CE to re-allocate the balance Rs.21.00 Cr. to the required divisions.
- 10) Decision was taken to convene coordination meetings under Chairmanship of CS to resolve the inter-departmental issues like railway, NHAI, land clearance, water permission etc.



**AGENDA-1: Review of follow-up action initiated by CE/PRED and other PRIs in pursuance of 20/11/2012  
SLSSC Proceedings**

The Agenda-wise compliance to the Proceedings of the SLSSC Meeting held on 20/11/2012 was presented before the Committee by CE, PRED and the following decisions were taken:

**Decision of SLSSC:**

Chairman instructed CE to discuss the pending issues at Government level every Monday and also instructed Director, SWSM to review implementation of progress of MVS.

**AGENDA-2: According approval to MVS Schemes deferred in the last meeting and which have been cleared  
by STA:**


**Subject-1: W/S/S to Illal & other 17 villages in Hungund taluk of Bagalkot District:**

Chief Engineer explained that, the earlier proposal wherein the source considered was Krishna River which is about 40 kms. away from Habitations. In the earlier proposal Per Capita was Rs.7485/- . In the SLSSC Meeting held on 17/9/2012 it was directed to re-verify the scheme and place it in the SLSSC Meeting. CE, PRED explained to the Committee that the source now considered for the Scheme is Malaprabha River. Malaprabha River is not perennial, hence an Impounding Reservoir is proposed to store water for 6 months. The total cost of the Project works out to Rs.3537.00lakhs including O&M for the proposed Project. Per Capita Cost for 2012 Population excluding O&M is Rs.7117/- . The Production Cost of water per KL is Rs.7.63/-.

**DECISION OF SLSSC**

After detailed deliberations the Committee took the following decision:

- 1) Mines & Geology Department to cross-check the Water Quality Reports for all the villages.



- 2) To place the proposal before STA for verification of other alternative technical proposals to reduce the cost of the Project.

### **AGENDA-3: Ratification of issues cleared by Govt. in anticipation of SLSSC approval**

The Tenders for the following 9 nos. of Multi-village schemes (including Additional Agenda) and 2 Tenders for Express Feeder line for MVS Schemes were forwarded to Government for approval as the Tender amount was either more than Rs.500.00 lakhs or Tender Premium was more than 5%. The Government have approved these Tenders with the condition to get the ratification on the action taken in the next S.L.S.S.C. meeting. #### DECISION OF SLSSC:

After detailed deliberations, Committee took the decision to ratify the action taken by Government of Karnataka.

#### AGENDA-4: New MVS Schemes / RWS proposals to be cleared.

35 Schemes proposed by Elected Representatives / Government amounting to Rs.51,110.16 lakhs including O&M Cost covering 672 habitations were placed before the Committee for consideration and approval for preparation of PSRs.

#### DECISION OF SLSSC:

The Committee directed to place the Subject in the next SLSSC Meeting after verifying the technical data, sustainability of source and viability of the Scheme at preliminary level. The SEs of concerned Circles are responsible to propose new Multi-village schemes for preparation of PSRs. The SEs should verify the Coverage and Quality, source sustainability, Per Capita Cost as per data available in IMIS. Any variations

in Quality parameters and Coverage parameters, SEs are responsible. Where MVS proposals do not meet the criteria as prescribed under NRDWP, such proposals should not be placed before SLSSC. The overlapping of the Projects (taken up in Jalanirmal, NRDWP, and 13th Finance) should be avoided strictly. The details of the Schemes are furnished vide Annexure-4.

#### **AGENDA-5: Any other subject with the permission of the Chair:**

**Subject No. 1:- Approval to DSRs for the Schemes which are cleared for PSR / DSR preparation in the S.L.S.S.C. Meeting held on 01/10/2011 & 10/4/2012:**

The CE, PRED explained to the Committee that 147 Schemes were approved for DSR preparation in the SLSSC Meeting held on 01/10/2011 and 28 Schemes are taken up under 13<sup>th</sup> Finance and 52 DSRs were placed till the last SLSSC Meetings. Out of this 50 Schemes are Administratively Approved including the 28 Schemes taken up under 13<sup>th</sup> Finance and 4 DSRs are placed in the present meeting for approval to accord Administrative Approval.


The CE, PRED also explained regarding splitting and combining of following Schemes in Mysore and Haveri Districts:


**Subject No. 2:-Approval for preparation of DSRs for which PSRs preparation was approved in S.L.S.S.C.**  
**Meeting held on 01/10/2011 & 29/6/2012:**


