#### What is Solution Exchange?

Initiated in 2005, Solution Exchange India is a knowledge facilitation service of the United Nations Country Team in India. Solution Exchange offers a unique approach to building capacities for addressing development challenges. Working through the modality of Communities of Practice (CoPs), Solution Exchange helps Community members to address the day-to-day issues they face, and to increase the effectiveness of their individual efforts. By tapping into the collective knowledge of diverse practitioners across this field, Solution Exchange connects colleagues who share interests and concerns, and who would like to learn from each other's knowledge and experience.

#### What is the Decentralization Community?

The Decentralization Community brings together individuals who are concerned with strengthening the institutions of local self government- the Panchayats and Municipal Bodies- to enable them to govern more effectively. The Decentralization Community deals with political, functional, administrative and financial decentralization in both rural and urban contexts, including those relating to sectoral decentralization, delivery of services, access to justice and other issues in local governance.

All members of the Community participate in a mail-group facilitated and moderated by a Resource Team located in UNDP, who helps members to connect, share and collaborate virtually as well as face-to-face. The Decentralization Community offers members the opportunity to also discuss specific issues in smaller sub-communities, formed around specific interest areas.

#### What are some of the issues to be covered by the Community?

The Decentralization Community focuses on issues related to decentralized governance in the light of the  $73^{rd}$  and  $74^{th}$  Amendments and on challenges and opportunities resulting from this framework for delivering services and programmes in different sectors and through various governmental and non-governmental channels:

- Renewing public interest and political buy-in for establishing effective local bodies as per the 73<sup>rd</sup> and 74<sup>th</sup> Amendments
- **Devolving powers and resources** from central and state authorities, for ensuring adherence to existing laws, including issues relating to fiscal decentralization
- **Ensuring clear accountability lines** functional boundaries and responsibilities of line agencies vis-a-vis local authorities; transfer of functions and functionaries; interrelationships between bodies working with similar objectives at various levels
- Building capacities of urban and rural local bodies
- Impact of decentralization on local economic development and poverty reduction
