PREAMBLE :

In Government Official Memorandum and Orders at (1) & (2) read above, the Procedure for release of grants to Zilla Panchayats/Taluk Panchayats has been issued. In Govt. Order cited at (3) accounting arrangements for Zilla Panchayats funds and Taluk Panchayats funds is prescribed. As per that Zilla Panchayats/Taluk Panchayats funds are split into 3 distinct category ie., ZP/TP fund-I, II & III. T.P. – Fund-II shall account for all receipts and expenditure in respect of all State Plan and Non-Plan schemes. Accordingly for the year 2012-13, 2nd quarter 2 months grant i.e. August 2012 and September 2012 already been released vide Government Order read cited (6) above, now considered for release of grants for the 3rd quarter i.e. October 2012 to December 2012. Hence the following order.

GOVT. ORDER NO:FD 2 ZPA 2012, BANGALORE, DATED: 7th September 2012

The Government are pleased to release a sum of Rs.194479.12 lakh (Rupees One lakh ninety four thousand four hundred seventy lakh and twelve thousand only) (on account) grants to Taluk Panchayats for the month of October 2012 to December 2012.

The details of the release under each major head are shown in Annexure appended to this order. Taluk Panchayats should follow order issued by Rural Development and Panchayat Raj Department. The grant released in this order shall be credited to concerned Taluk Panchayats under T.P. Fund –II.

The Z.Ps. should not draw the funds released for Taluk Panchayats coming under them. The Z.Ps. should issue Taluk Panchayats wise allocation and the Taluk Panchayat, should adjust these grants to Taluk Panchayat Fund-II through TTR. The Taluk Panchayats shall release the grant to the Drawing Officer shown as per new scheme codes in the link documents, DDOs will draw through the Treasuries. The Drawing and Disbursing Officers under Taluk Panchayats shall be directed to use the scheme codes while submitting the bills to the Treasuries.

These grants shall be met out of the budget provision of the year 2012-13 under the Heads of Account indicated in annexure appended to this order.
