

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Payment of interest to Panchayat Raj Institutions for the delay in the release of 14th Finance Commission Grants for the year 2015-16 under.

Preamble:

Government of India, Ministry of Finance, had released Rs.50143.00 lakhs as 1st instalment of Basic Grants under 14th Finance Commission. The same had been released in two spells i.e. Rs. 47306.44 lakhs to 5557 Gram Panchayats vide Government Order read at (1) above. Due to technical problems Rs.2127.41 lakhs were released to 449 Gram Panchayats vide Government Order read at (2) above. As there has been delay of 7 to 170 days excluding 15 days prescribed for the release of grants. In order to obtain 2nd instalment of Basic Grants from Government of India, the State Government is required to release the interest amount to the Gram Panchayats. Finance Department vide its Note read at (3) above has agreed to release Rs.118.63 lakhs interest on the above releases of Rs.49433.85 lakhs under the head of account:2515-00-198-6-11-300 lumpsum (N.P.). The interest amount of Rs.118.63 lakhs will be provided in S.E.III 2015-16 to restore the Budget provision for the activities of the 14th Finance Commission grants for the year 2015-16. Hence the following order.

The matter has been examined in detail and it is hereby ordered to release the amount of Rs. 118.63 lakhs (Rs. One hundred and eighteen lakhs sixty three thousand only) for the delay ranging from 7 to 170 days caused in the release of 1st Instalment of General Basic Grants under 14th Finance Commission Grants to the Gram Panchayats under the head of account:2515-00-198-6-11-300 lumpsum (N.P.).

Under Secretary (ZP), Rural Development and Panchayat Raj Department is accorded permission to upload the 14th Finance Commission Grants through Treasury Network Management Centre, Bangalore to the respective Zilla Panchayat D.D.O.Codes (Drawing & Disbursing Codes.)

The Chief Executive Officers of the Zilla Panchayats shall release Rs.1900/- (One thousand nine hundred only) equally among all the Grama Panchayats in their districts.
