

**PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA**

**Sub:** Payment of interest to Panchayat Raj Institutions for the delay in the release of 14<sup>th</sup> Finance Commission Grants for the year 2015-16 under.

**Preamble:**

Government of India, Ministry of Finance, had released Rs.50143.00 lakhs as 1<sup>st</sup> instalment of Basic Grants under 14<sup>th</sup> Finance Commission. The same had been released in three spells i.e. Rs. 47306.44 lakhs to 5557 Gram Panchayats vide Government Order read at (1) above. Rs.2127.41 lakhs were released to 449 Gram Panchayats vide Government Order read at (2) above and Rs.709.13 lakhs vide Government Order read at (3) above. Due to technical problems there has been a delay of 201 days excluding 15 days prescribed for the release of grants. In order to obtain 2<sup>nd</sup> instalment of Basic Grants from Government of India, the State Government is required to release the interest amount to the Gram Panchayats. Finance Department vide its Note read at (4) above has agreed to release Rs.24.41 lakhs interest on Rs.709.13 lakhs under the head of account: 2515-00-198-6-11-300 lumpsum (N.P.). The interest amount of Rs.24.41 lakhs will be provided in S.E.III 2015-16 to restore the Budget provision for the activities of the 14<sup>th</sup> Finance Commission grants for the year 2015-16. Hence the following order.

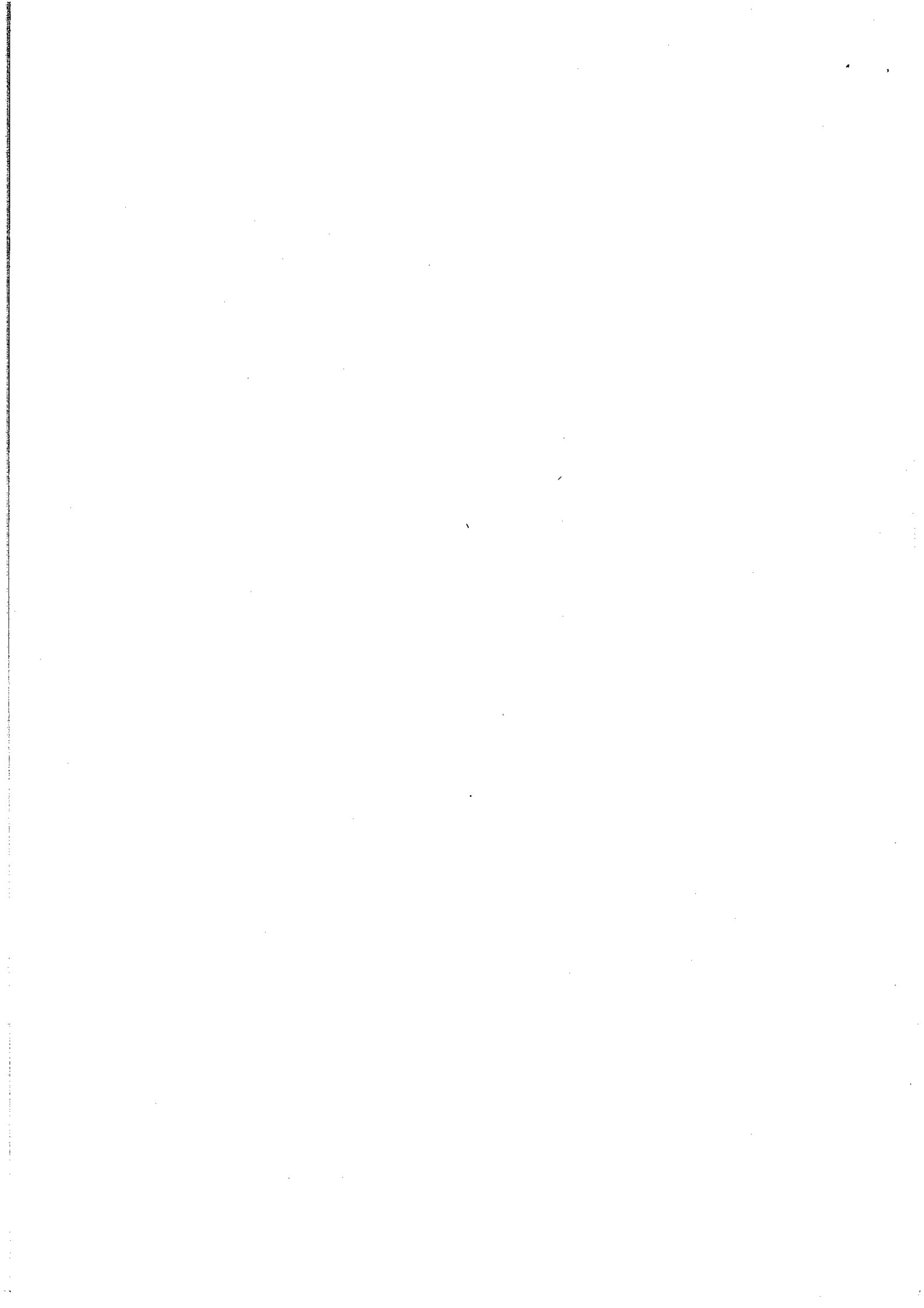
**GOVERNMENT ORDER NO. RDP 44 GPS 2015, DATED:09.03.2016.**

The matter has been examined in detail and it is hereby ordered to release the amount of Rs.24.41 lakhs (Twenty four lakhs forty one thousand rupees only) for the delay of 201 days caused in the release of 1<sup>st</sup> Instalment of General Basic Grants under 14<sup>th</sup> Finance Commission Grants to the Gram Panchayats under the head of account:2515-00-198-6-11-300 lumpsum (N.P.).

Under Secretary (ZP), Rural Development and Panchayat Raj Department is accorded permission to upload the 14<sup>th</sup> Finance Commission Grants through Treasury Network Management Centre, Bangalore to the respective Zilla Panchayat D.D.O.Codes (Drawing & Disbursing Codes.)

The Chief Executive Officers of the Zilla Panchayats shall release Rs.405/- (Four hundred and five only) equally among all the Grama Panchayats in their districts.


