

## **PROCEEDINGS OF GOVERNMENT OF KARNATAKA**

Sub      Adoption and applicability of the State Level Standing Committee of PMGSY (as constituted under PMGSY) to State Programme of Namma Grama Namma Raste Yojane Scheme.

### **PREAMBLE:**

Vide Government Order read at -1 above, the State Level Standing Committee of PMGSY was constituted under the Chairmanship of Additional Chief Secretary & Development Commissioner to clear annual project proposals. This committee apart from clearing annual proposals shall also meet quarterly to review and monitor the programme to oversee the timely and proper execution of the works.

Karnataka Rural Road Development Agency, the State level nodal agency for PMGSY, is also implementing State funded scheme of Namma Grama Namma Raste Yojane wherein 20/30 Kms. roads are improved in each of the 189 rural Assembly Constituency. In addition administrative approval has been issued vide G.O.NO. RDP.6.RRC.2015, dt:31-3-2015 for improvement of 20 Kms. in each of 189 rural Assembly Constituency under NGNRY phase-III. The improvement of rural roads under NGNRY is being taken up duly following the PMGSY criteria and Guidelines as indicated in the Government Orders.

Recently during the performance audit of NGNRY, the Accountant General (Audit) has highlighted the need to adhere to the PMGSY Guidelines as regards to SLSC and its functions. The SLSC has to vet the CNW, CUPL and annual road plan proposals, consider policy issues relating to CNW, training, capacity building, inter departmental co-ordination, close and effective monitoring of the programme including overseeing the timely and proper execution of works.



As per the guidelines of the scheme there shall be an SLSC for PMGSY which shall

- (i) Monitor Progress & Quality control
- (ii) Resolve issues relating to Land availability & Forest/Environmental clearance
- (iii) Oversee maintenance funding arrangements for the CNW
- (iv) Review capacity at SRRDA & PIU levels including financial management & online monitoring
- (v) Ensure convergence of development programme including transport facilities on the constructed roads

The constitution of this committee is also applicable to Namma Grama Namma Raste Yojane and other schemes being implemented through Karnataka Rural Road Development Agency.


