NOTIFICATION

The draft of the following rules further to amend the Karnataka Panchayat Raj Engineering Services (Cadre & Recruitment) Rules, 2008, which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is hereby published as required by clause (a) of sub-section (2) of section 3 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration after fifteen days from the date of its publication in the Official Gazette.

Any objection or suggestion which may be received by the State Government from any person with respect to the said draft rules before the expiry of the period specified above will be considered by the State Government. Objections and suggestions may be addressed to the Principal Secretary to Government, Rural Development and Panchayat Raj Department, M.S.Building, Dr. B.R. Ambedkar Veedhi, Bangalore-560 001.

DRAFT RULES

1. **Title and commencement:** - (1) These rules may be called the Karnataka Panchayat Raj Engineering Services (Cadre and Recruitment) (Amendment) Rules, 2013.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. **Amendment of Schedule-II:-** In Karnataka Panchayat Raj Engineering Services (Cadre and Recruitment) Rules, 2008 in schedule-II:-

(1) in the entries relating to the category of post of "Superintendents cadre" at Serial No.10:-

- (a) Clause (ii) and entries relating there to shall be omitted;
- (b) Clause (iii) shall be renumbered as clause (ii); and

(2) After the category of post of "Superintendents cadre" at Serial No.10 and entries relating thereto, the following shall be inserted, namely:-

10A. Accounts Superintendents	Fifty percent by deputation in the equivalent cadre from the State Accounts Department; and forty five percent by promotion from the cadre of First Division Accounts Assistant; and five percent by transfer from the cadre of Office Superintendent on the basis of Seniority.	<p>For Promotion and Transfer:-</p> <p>(1) Must have put in a service of not less than five years in the cadre of First Division Accounts Assistant or Office Superintendent as the case may be,</p> <p>If no suitable person with not less than five years of service is available, a person with not less than three years of service may be considered for promotion / transfer.</p> <p>(2) Must have passed S.A.S. Examination</p> <p>(3) A person with computer knowledge be preferred.</p>

(3) in the entries relating to the category of post of "First Division Assistant" at Serial No.17:-

- (a) Clause (ii) and entries relating thereto shall be omitted;
- (b) Clause (iii) shall be renumbered as clause (ii) and clause (iv) shall be renumbered as clause (iii); and

(4) after the category of post of "First Division Assistant" at Serial No. 17, and entries relating thereto, the following shall be inserted, namely:-

17A. First Division Accounts Assistant	Fifty percent by deputation in the equivalent cadre from the State Accounts Department; and thirty percent by transfer from the cadre of First Division Assistant. An irrevocable option from the First Division Assistant shall be obtained before such transfer to the effect that the candidate will continue to remain in the cadres of Accounts Division and twenty percent by promotion from the cadre of Second Division Accounts Assistants on the basis of seniority.	<p>For Promotion and Transfer :-</p> <p>(1) Must have passed S.A.S. Examination.</p> <p>(2) Must have put in a service of not less than five years in the cadre of First Division Assistant or Second Division Accounts Assistant as the case may be,</p> <p>If no person who has put in a service of not less than five years of service is available, the persons who have put in a service of not less than three years may be considered for promotion / transfer.</p>

(5) in the entries relating to the category of post of "Second Division Assistant" at Serial No. 21:-

- (a) Clause (ii) shall be omitted; and
- (b) Clause (iii) shall be renumbered as clause (ii); and


(6) after the category of post of "Second Division Assistant" at Serial No. 21 and entries relating thereto, the following shall be inserted, namely:-

<p>21A. Second Division Accounts Assistant</p>	<p>Fifty percent by deputation of an official in equivalent cadre from the State Accounts Department; and fifty percent by transfer from the cadre of Second Division Assistant on the basis of seniority.</p> <p>An irrevocable option from the Second Division Assistant shall be obtained before transfer to the post of Second Division Accounts Assistant to the effect that the candidate shall continue in the cadres of Accounts Division.</p>	<p>For Transfer :- (1) Must have passed S.S.L.C. or equivalent examination.</p> <p>(2) Must have obtained a 'O' level certificate in the Course on Computer Concepts issued by any of the recognized Societies of DOEACC, an Autonomous body of the Department of Information Technology, Ministry of Communications and Information Technology, Government of India.</p>
