NOTIFICATION

The draft of the following rules further to amend the Karnataka General Service (Development Branch and Local Government Branch) (Cadre and Recruitment) Rules, 2008, which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is here by published as required by clause (a) of sub-section (2) of section 3 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in the Official Gazette.

Any objection and suggestion which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above will be considered by the State Government. DRAFT RULES


1. **Title and commencement:-** (1) These rules may be called the Karnataka General Services (Development Branch and Local Government Branch) (Cadre and Recruitment) (Amendment) Rules, 2019.

(2) They shall come into force from the date of their final publication in the Official Gazette.

2. **Amendment of the Schedule:-** In the Karnataka General Services (Development Branch and Local Government Branch) (Cadre and Recruitment) Rules, 2008, in the Schedule, in the entries relating to the category of post of "Gram Panchayat Secretary and Rural Development Assistant(Grade-II)", at serial number 10, in column number (5) under the sub-heading "for Direct Recruitment by selection", the following proviso shall be inserted at the end, namely:-

"Provided that, pass in pre-university course or equivalent qualification prescribed as qualification for direct recruitment by selection shall not be applicable for full time Secretaries, Clerks, Accountants, Typists or Bill-Collectors in the erstwhile Village Panchayats or Mandal Panchayats or in the Grama Panchayat who are already in service possessing SSLC qualification or equivalent qualification on the date of commencement of the Karnataka Civil Services (Recruitment to the Ministerial posts) (Amendment) Rules, 2013", which came into effect from 02-01-2014.
